## MINUTES OF THE CITY COUNCIL

THURSDAY, NOVEMBER 12, 2009

**SPECIAL MEETING                      9:00 AM                      COUNCIL CHAMBERS**

This Special meeting of the Oceanside City Council was called by Councilmembers Feller, Chavez and Kern in accordance with the special meeting notice requirements for the items listed below.

**MAYOR WOOD** convened this special meeting at 9:00 am. Present were Mayor Wood and Councilmembers Jack Feller, Rocky Chavez and Jerry Kern. Councilmember Esther Sanchez was absent. Also present were City Clerk Barbara Riegel Wayne, City Manager Peter Weiss, City Attorney John Mullen and City Treasurer Gary Felien.

**ADOPTION OF ORDINANCE ITEMS:**

1. **City Council: Adoption of an ordinance of the City of Oceanside amending Oceanside City Code, Chapter 29, establishing sewer user rate increases** *(introduced on 11/4/09, 3-1 vote – Sanchez-absent, Wood-no)*

and

2. **City Council: Adoption of an ordinance of the City of Oceanside amending Oceanside City Code, Chapter 37, establishing water user rate and external water provider charge increases** *(introduced on 11/4/09, 3-1 vote – Sanchez-absent, Wood-no)*

**CITY ATTORNEY MULLEN** noted that Council has already conducted the Proposition 218 public hearing and held 2 prior workshops in a Council meeting where this was item was reintroduced.

Public input

**WILLIE LITTLE**, 3201 Mesa Drive, expressed concerns with the increased rates and we see little results, i.e. there is little interest in how to keep the rates down. We need Council to look at how to run this without the rate payers paying more.

Following the reading of the titles, **COUNCILMEMBER CHAVEZ** moved to adopt both ordinances [**Ordinance No. 09-OR0756-1**, "...amending Oceanside City Code, Chapter 29, establishing sewer user rate increases"; and **Ordinance No. 09-OR0757-1**, "...amending Oceanside City Code, Chapter 37, establishing water user rate and external water provider charge increases"].

**COUNCILMEMBER FELLER** seconded the motion.

**Motion was approved 3-1, Wood – no, Sanchez – absent.**
