SUBJECT: **FINAL MAP MORRO HILLS VILLAGE K**

SYNOPSIS

Staff recommends that the City Council adopt a resolution approving the Final Map for the Morro Hills Village K project, and authorize the recordation of the Final Map with the San Diego County Recorder.

BACKGROUND

Morro Hills Village K is a 125-lot residential project located on 33.410 acres on Vista Pointe Boulevard & Bellingham Drive. The owner of the property is Toll Land XX Limited Partnership, a California Limited Partnership.

On January 10, 2011, the Planning Commission adopted Resolution No. 2011-P01 approving the Tentative Map.

Exhibit A is a vicinity map showing the aforementioned property.

ANALYSIS

All financial arrangements have been satisfactorily completed. All pertinent documents have been properly executed by the applicant. All grading and drainage comply with City ordinances.

The map is consistent with applicable general and specific plans and the site is physically suitable for the type of development. Conditions and restrictions have been imposed to ensure its compatibility with adjacent areas and the entire City.

FISCAL IMPACT

The development fees, required as a condition of map approval, will be imposed.

Does not apply.


CITY ATTORNEY'S ANALYSIS

The City Attorney reviewed and approved the resolution as to form.


RECOMMENDATION


