SUBJECT: **FINAL MAP LA COSTA VILLAS (CONDOMINIUMS)**

SYNOPSIS

Staff recommends that the City Council adopt a resolution approving the Final Map for the La Costa Villas, a condominium project on the north end of North River Circle and authorize the recordation of the Final Map with the San Diego County Recorder.

BACKGROUND

La Costa Villas is a 1-lot, 22-unit condominium project, located on 1.49 acres on the north end of North River Circle. The owner of the property is N. River Road LLC.

On November 7, 2005, the Planning Commission adopted Resolution No. 2005-P51 approving the Tentative Map.

Exhibit A is a vicinity map showing the aforementioned property.

ANALYSIS

All financial arrangements have been satisfactorily completed. All pertinent documents have been properly executed by the applicant. All grading and drainage comply with City ordinances.

The map is consistent with applicable general and specific plans and the site is physically suitable for the type of development. Conditions and restrictions have been imposed to ensure its compatibility with adjacent areas and the entire City.

FISCAL IMPACT

The development fees, required as a condition of map approval, will be imposed.

CITY ATTORNEY'S ANALYSIS


The resolution and map have been reviewed by the City Attorney and approved as to form.






