On August 12, 2009, the Oceanside City Council adopted Resolution Number 09-R0519-1 establishing the 2010 meeting schedule of dates and times for regular meetings. On December 2, 2009, Council adopted Resolution Number 09-R0794-1 amending the 2010 dates and times.

The established meeting schedule only provides for a single regular meeting in July, leaving no meeting between July 14 and August 11. Council Member Esther Sanchez requests that an additional meeting be added to the 2010 meeting schedule of dates and times. Attachment A indicates the dates for a potential regular meeting, highlighted in red, which fall on the usual Wednesday pattern; those dates being July 21, July 28, and August 4. The specific date to be set for the additional regular meeting is left to the discretion of Council.
