SUBJECT: **ADOPTION OF RESOLUTIONS OF THE CITY COUNCIL OF THE CITY OF OCEANSIDE, ACTING IN ITS CAPACITY AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICTS NO. 2000-1 (OCEAN RANCH), NO. 2001-1 (MORRO HILLS) AND NO. 2001-2 (TRENDWEST RESORTS), AUTHORIZING THE LEVIES OF SPECIAL TAXES FOR FISCAL YEAR 2007-2008**

SYNOPSIS

Staff recommends that the City Council adopt the attached resolutions authorizing the levy of special taxes for Community Facilities Districts 2000-1 (Ocean Ranch), 2001-1 (Morro Hills), and 2001-2 (Trendwest Resorts) for the fiscal year 2007-2008.

BACKGROUND

The Mello-Roos Community Facilities Act was enacted in 1982 to provide alternate means for financing infrastructure following the passage of Proposition 13. The Act allows cities, counties and special districts to create defined areas within their jurisdiction and, by a two-thirds vote within the area, impose special taxes to pay for the public improvements and services required by the area. The Community Facility District (CFD) may provide for the purchase, construction, expansion, or rehabilitation of any real or tangible property with a useful life of at least five years. The CFD may also finance soft costs, such as planning and consulting, involved in the formation of the CFD.

There are three CFDs being addressed under these resolutions. These are the Ocean Ranch Corporate Centre, the Morro Hills Development, and Trendwest Resorts.

The Ocean Ranch Corporate Centre, CFD 2000-1, is an industrial subdivision of approximately 289 net developable acres. The site is located north of Oceanside Boulevard and west of College Boulevard. On March 7, 2001, the landowners within Ocean Ranch Corporate Centre voted to incur indebtedness and issue bonds in the maximum amount of \$25 million. The first bond issue took place in December 2002 for a face value of \$12,265,000. The second bond issue took place in November 2004 for a face value of \$12,735,000.

Morro Hills Development, CFD 2001-1, is a master-planned community of approximately 588 acres located in northeastern Oceanside's San Luis Rey Valley, just south of the intersection of Vandegrift Road and Douglas Drive. One thousand seven (1,007) residential units are being developed in this CFD around an 18-hole championship public golf course. The master plan also includes a public park, elementary school, village center, country store, church, and daycare center. In October 2002, the City issued the first phase of bonds in the amount of \$9,915,000. The second phase of bonds was issued in February 2004 in the amount of \$11,000,000 to finance construction of infrastructure improvements required for the development of the property within Improvement Area No. 1 within the District. The final phase of bonds was issued in December 2004 for a face value of \$16,085,000.

Finally, Trendwest Resorts, CFD 2001-2, is a 140-unit vacation resort near the Oceanside Harbor and San Luis Rey River which opened in November 2001. The project was approved in July of 1999 and included an Owner Participation Agreement (OPA) between the City Community Development Commission (CDC) and Trendwest Resorts. Under this agreement, the City agreed to compensate the developer for certain improvements deemed to have wide public benefit. These improvements included additions to and improvements of public parking facilities, right-of-way and curb construction on Riverside Drive and Goodland Drive, traffic signals, relocation of water lines and construction of a fire hydrant water line. In June 2002, the City issued \$1,500,000 in bonds for the improvements at Trendwest.

The special tax levy began for CFD 2001-2 (Trendwest Resorts) in tax year 2002-2003. In tax year 2003-2004 the special tax levies began for CFDs 2000-1 (Ocean Ranch) and 2001-1 (Morro Hills). Council has approved the special tax levies each year.

ANALYSIS

A Community Facilities District is a public finance tool to provide infrastructure for new development that has a broad public benefit. The underlying principles contained in the City's CFD policy are that the public interest is protected, that there is fairness in the application of the special taxes, that there is full disclosure to potential buyers, and that the City's financial position is protected. The City must find that significant public benefit would occur from the formation of a CFD.

The attached resolutions levy the special taxes for Ocean Ranch, Morro Hills and the Trendwest Resorts Community Facilities Districts for FY 2007-2008.

FISCAL IMPACT

The Special Tax Requirement for the respective CFDs is as follows:

Ocean Ranch	\$1,560,623.60
Morro Hills	\$1,861,497.98
Morro Hills Improvement Area No. 1	\$ 800,434.08
Trendwest Resorts	\$ 117,250.00

These special tax assessments will result in total revenue of \$4,339,805.66 that is dedicated to paying debt incurred in the formation of the CFDs and for ancillary costs associated with the administration of the districts.



RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OCEANSIDE, ACTING IN ITS CAPACITY AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT NO. 2000-1 OF THE CITY OF OCEANSIDE (OCEAN RANCH CORPORATE CENTRE) AUTHORIZING THE LEVY OF A SPECIAL TAX FOR FISCAL YEAR 2007-08

WHEREAS, on March 7, 2001, the City Council of the City of Oceanside (the "City Council") adopted Resolution No. 01-R116-1 stating its intention to form Community Facilities District No. 2000-1 of the City of Oceanside (Ocean Ranch Corporate Centre) ("Community Facilities District No. 2000-1") pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, Section 53311 *et seq.* of the Government Code (the "Act"); and

WHEREAS, on March 7, 2001, the City Council also adopted Resolution No. 01-R117-1 stating its intention to incur bonded indebtedness in the amount of \$25,000,000 within proposed Community Facilities District No. 2000-1 for the purpose of financing the facilities and incidental expenses described in Resolution No. 01-R116-1 to serve the area within Community Facilities District No. 2000-1; and

WHEREAS, on May 2, 2001, the City Council adopted Resolution No. 01-R263-1 which established Community Facilities District No. 2000-1, authorized the levy of a special tax within Community Facilities District No. 2000-1 and called an election within Community Facilities District No. 2000-1 on the ballot proposition relating to levying a special tax combined and consolidated with the proposition relating to the incurring of bonded indebtedness; and

WHEREAS, on May 2, 2001, the City Council also adopted Resolution No. 01-R264-1 which determined the necessity to incur bonded indebtedness in the amount of \$25,000,000 within Community Facilities District No. 2000-1 and called an election within Community Facilities District No. 2000-1 for May 15, 2001, on the proposition of incurring bonded indebtedness combined and consolidated with the proposition of levying a special tax; and

1 WHEREAS, on May 15, 2001, an election was held within Community Facilities District No.
2 2000-1 at which the qualified electors approved by more than a two-thirds vote the proposition of
3 incurring bonded indebtedness of \$25,000,000 and levying a special tax as set forth in Resolution
4 No. 01-R263-1; and

5 WHEREAS, on July 11, 2001, the City Council adopted Resolution No. 01-R406-1 which
6 certified the results of the May 15, 2001 election conducted by the City Clerk, which results showed
7 that more than two-thirds of the votes cast were in favor of the proposition to incur bonded
8 indebtedness and levy the special tax; and

9
10 WHEREAS, on July 18, 2001, the City Council adopted Ordinance No. 01-OR439-1 which
11 authorized the levy of the special tax within Community Facilities District No. 2000-1; and

12 WHEREAS, this City Council hereby certifies that the Ordinance authorizing the levy of the
13 special taxes within Community Facilities District No. 2000-1 has been duly adopted in accordance
14 with law and is legal and valid; and

15 WHEREAS, subsequent to the adoption of Ordinance No. 01-OR439-1, the City Council
16 determined that public necessity and convenience required that the rate and method of apportionment
17 of the special tax, described in Ordinance No. 01-OR439-1 and approved by the qualified electors
18 within the District at the special election held on May 15, 2001, should be changed; and

19
20 WHEREAS, the City Council adopted Resolution No. 04-R533-1 on August 4, 2004 setting
21 forth in Exhibit A thereto the proposed amendments to the rate and method of apportionment of the
22 special tax, expressing its intention to consider the proposed amendments and calling a public
23 hearing on September 15, 2004 as required by Section 53338 of the Act; and

24 WHEREAS, on September 15, 2004, the City Council held a public hearing regarding the
25 proposed amendments to the rate and method of apportionment of the special tax in accordance with
26 the requirements of Section 53338 of the Act at the conclusion of which the City Council determined
27 to submit the proposed amendments to a vote of the qualified electors of the District and adopted
28

1 Resolution No. 04-R821-1 calling an election on the proposition to approve the proposed
2 amendments; and

3 WHEREAS, the election on the proposition regarding the proposed amendments was held on
4 September 15, 2004, and thereafter on September 15, 2004, the City Clerk canvassed the election
5 results and certified that more than two-thirds of the votes cast were in favor of such proposition; and

6 WHEREAS, on September 15, 2004, the City Council adopted Resolution No. 04-822-1 as a
7 resolution of change in accordance with Section 53338(b) of the Act, which declared the proposed
8 amendments to the rate and method of apportionment of the special tax to be effective; and

9 WHEREAS, on October 6, 2004, the City Council enacted Ordinance No. 04-0R869-1
10 amending in part Ordinance No. 01-0R439-1 (as amended, the "Ordinance") to authorize the levy of
11 a special tax within the District in accordance with the amended rate and method of apportionment of
12 the special tax commencing in Fiscal Year 2005-06 and each Fiscal Year thereafter for the purposes
13 set forth in Resolution No. 01-R263-1 and Resolution No. 04-822-1; and

14 WHEREAS, the Ordinance provides that the City Council is further authorized to determine,
15 by ordinance, or by resolution if permitted by then applicable law, on or before August 10 of each
16 year, the specific special tax to be levied on each parcel of land in Community Facilities District
17 No. 2000-1; and

18 WHEREAS, it is now necessary and appropriate that this City Council levy and collect the
19 special taxes for Fiscal Year 2007-08 for the purpose specified in the Ordinance, by the adoption of a
20 resolution as specified by the Act and the Ordinance; and

21 WHEREAS, the special taxes being levied hereunder are at the same rate or at a lower rate
22 than provided by the Ordinance;

23 NOW, THEREFORE, the City Council of the City of Oceanside acting in its capacity as the
24 legislative body of Community Facilities District No. 2000-1 does resolve as follows:

25 Section 1. The above recitals are all true and correct.
26

1 Section 2. In accordance with Section 53340 of the Act and the Ordinance, there is hereby
2 levied upon the parcels within the District which are not otherwise exempt from taxation under the
3 Act or the Ordinance the special taxes for Fiscal Year 2007-08 (the "Special Taxes"), at the tax rates
4 set forth in Exhibit A hereto and the Special Tax Consultant shall apportion the Special Taxes in the
5 manner specified in Resolution No. 04-R822-1 and the report prepared by the Special Tax Consultant
6 entitled "Administration Report Fiscal Year 2007-08" submitted herewith. Such rates do not exceed
7 the maximum rates set forth in the Ordinance. After adoption of this Resolution, but no later than
8 August 10, 2007, the Special Tax Consultant shall deliver the certified list of all parcels subject to the
9 special tax levy including the amount of the Special Taxes to be levied on each parcel in Fiscal Year
10 2007-08 (the "Certified List") to the Financial Services Director or her designee and thereafter, but in
11 no event later than August 10, 2007, the Financial Services Director or her designee shall cause a
12 certified copy of this Resolution together with the Certified List, to be filed with the County Auditor-
13 Controller. The Certified List may contain tax rates lower than those set forth in Exhibit A if the
14 Financial Services Director determines that such lower rates are adequate to accomplish the purposes
15 of the District in Fiscal Year 2007-08. The Financial Services Director or her designee and the
16 County Auditor-Controller are hereby authorized to make changes to the Certified List from time to
17 time to correct any error in the amount of the levy on any parcel to make it consistent with the rate
18 and method of apportionment attached to the Ordinance, including, but not limited to, adding any
19 parcels omitted from the Certified List or deleting any parcels included in the Certified List.

22 Section 3. Properties or entities of the state, federal or local governments shall be exempt
23 from the above-referenced and approved Special Taxes only to the extent set forth in the Ordinance
24 and otherwise shall be subject to the Special Taxes consistent with the provisions of Section 53317.3
25 of the Act in effect as of the date of adoption of this Resolution.

26 Section 4. All of the collections of the Special Taxes shall be used only as provided for in the
27 Act and Resolution No. 01-R263-1 and Resolution No. 04-822-1. The Special Taxes shall be levied
28

1 only so long as needed to accomplish the purposes described in Resolution No. 01-R263-1 and
2 Resolution No. 04-822-1.

3 Section 5. The Special Taxes shall be collected in the same manner as ordinary ad valorem
4 taxes are collected and shall be subject to the same penalties and the same procedure, sale and lien
5 priority in cases of delinquency as provided for ad valorem taxes as such procedure may be modified
6 by law or this City Council from time to time.

7
8 Section 6. As a cumulative remedy, if any amount levied as the Special Taxes for payment
9 of interest or principal on any outstanding bonds of the District (the "Bonds"), together with any
10 penalties and other charges accruing under this Resolution, are not paid when due, the City Council
11 may, not later than four years after the due date of the last installment of principal on the Bonds,
12 order that the same be collected by an action brought in the superior court to foreclose the lien of
13 such Special Taxes.

14 Section 7. The Financial Services Director or her designee is hereby authorized to transmit a
15 certified copy of this Resolution, together with the Certified List, to the County Assessor and/or the
16 Treasurer-Tax Collector, together with other supporting documentation as may be required to place
17 the Special Taxes on the secured property tax roll for Fiscal Year 2007-08 and for the collection of
18 the Special Taxes in the manner of ad valorem property taxes and to perform all other acts which are
19 required by the Act, the Ordinance, or by law or deemed necessary by the Financial Services Director
20 in order to accomplish the purpose of this Resolution, the Act or Bond covenants.

21
22 Section 8. This Resolution shall be effective upon its adoption.

9 indebtedness of \$11,000,000 and the levying of a special tax within Improvement Area No. 1 as set
10 forth in Resolution No. 02-R185-1; and

11 WHEREAS, on April 17, 2002, the City Council adopted Resolution No. 02-R305-1 which
12 certified the results of the March 26, 2002 elections conducted by the City Clerk, which results
13 showed that more than two-thirds of the votes cast were in favor of the proposition to incur bonded
14 indebtedness and levy the special tax within both Community Facilities Districts No. 2001-1; and

15 WHEREAS, on May 1, 2002, the City Council adopted Ordinance No. 02-OR326-1 which
16 authorized the levy of the special tax within Community Facilities District No. 2001-1 and within
17 Improvement Area No. 1 (the "Ordinance"); and

18 WHEREAS, this City Council hereby certifies that the Ordinance authorizing the levy of the
19 special taxes within Community Facilities District No. 2001-1 and within Improvement Area No. 1
20 has been duly adopted in accordance with law and is legal and valid; and

21 WHEREAS, the Ordinance provides that the City Council is further authorized to determine,
22 by ordinance, or by resolution if permitted by then applicable law, on or before August 10 of each
23 year, the specific special tax to be levied on each parcel of land in Community Facilities District No.
24 2001-1 and within Improvement Area No. 1; and

1 WHEREAS, it is now necessary and appropriate that this City Council levy and collect the
2 special taxes for Fiscal Year 2007-08 for the purpose specified in the Ordinance, by the adoption of a
3 resolution as specified by the Act and the Ordinance; and

4 WHEREAS, the special taxes being levied hereunder are at the same rate or at a lower rate
5 than provided by the Ordinance;

6 NOW, THEREFORE, the City Council of the City of Oceanside acting in its capacity as the
7 legislative body of Community Facilities District No. 2001-1 does resolve as follows:
8

9 Section 1. The above recitals are all true and correct.

10 Section 2. In accordance with Section 53340 of the Act and the Ordinance, there is hereby
11 levied upon the parcels within the Community Facilities District No. 2001-1 which are not otherwise
12 exempt from taxation under the Act or the Ordinance the special taxes for Fiscal Year 2007-08 (the
13 “Special Taxes”), at the tax rates set forth in Exhibit A hereto and there is hereby levied upon the
14 parcels within Improvement Area No. 1 which are not otherwise exempt from taxation under the Act
15 or the Ordinance the Special Taxes for Fiscal Year 2007-08 (the “Improvement Area No. 1 Special
16 Taxes”), at the tax rates set forth in Exhibit B hereto. The Special Tax Consultant shall apportion the
17 Special Taxes and the Improvement Area No. 1 Special Taxes in the manner specified in Resolution
18 No. 02-R185-1 and the report prepared by the Special Tax Consultant entitled “Administration
19 Report Fiscal Year 2007-08” submitted herewith. Such rates do not exceed the maximum rates set
20 forth in the Ordinance. After adoption of this Resolution, but no later than August 10, 2007, the
21 Special Tax Consultant shall deliver the certified list of all parcels subject to the special tax levy
22 including the amount of the Special Taxes and the Improvement Area No. 1 Special Taxes to be
23 levied on each parcel in Fiscal Year 2007-08 (the “Certified List”) to the Financial Services Director
24 or her designee and thereafter, but in no event later than August 10, 2007, the Financial Services
25 Director or her designee shall cause a certified copy of this Resolution together with the Certified
26 List, to be filed with the County Auditor-Controller. The Certified List may contain tax rates lower
27
28

1 than those set forth in Exhibit A and Exhibit B if the Financial Services Director determines that such
2 lower rates are adequate to accomplish the purposes of the District and Improvement Area No. 1 in
3 Fiscal Year 2007-08. The Financial Services Director or her designee and the County Auditor-
4 Controller are hereby authorized to make changes to the Certified List from time to time to correct
5 any error in the amount of the levy on any parcel to make it consistent with the respective rate and
6 method of apportionment for Community Facilities District No. 2001-1 and for Improvement Area
7 No. 1 attached to the Ordinance, including, but not limited to, adding any parcels omitted from the
8 Certified List or deleting any parcels included in the Certified List.
9

10 Section 3. Properties or entities of the state, federal or local governments shall be exempt
11 from the above-referenced and approved Special Taxes and Improvement Area No. 1 Special Taxes
12 only to the extent set forth in the Ordinance and otherwise shall be subject to the Special Taxes and
13 Improvement Area No. 1 Special Taxes consistent with the provisions of Section 53317.3 of the Act
14 in effect as of the date of adoption of this Resolution.

15 Section 4. All of the collections of the Special Taxes and Improvement Area No. 1 Special
16 Taxes shall be used only as provided for in the Act and Resolution No. 02-R185-1. The Special
17 Taxes and Improvement Area No. 1 Special Taxes shall be levied only so long as needed to
18 accomplish the purposes described in Resolution No. 02-R185-1.
19

20 Section 5. The Special Taxes and Improvement Area No. 1 Special Taxes shall be collected
21 in the same manner as ordinary ad valorem taxes are collected and shall be subject to the same
22 penalties and the same procedure, sale and lien priority in cases of delinquency as provided for ad
23 valorem taxes as such procedure may be modified by law or this City Council from time to time.

24 Section 6. As a cumulative remedy, if any amount levied as the Special Taxes or the
25 Improvement Area No. 1 Special Taxes for payment of interest or principal on any outstanding bonds
26 of the District (the "District Bonds") or of Improvement Area No. 1 (the "Improvement Area No. 1
27 Bonds"), respectively, together with any penalties and other charges accruing under this Resolution,
28

1 are not paid when due, the City Council may, not later than four years after the due date of the last
2 installment of principal on the Bonds or Improvement Area No. 1 Bonds, order that the same be
3 collected by an action brought in the superior court to foreclose the lien of such Special Taxes or
4 Improvement Area No. 1 Special Taxes.

5 Section 7. The Financial Services Director or her designee is hereby authorized to transmit a
6 certified copy of this Resolution, together with the Certified List, to the County Assessor and/or the
7 Treasurer-Tax Collector, together with other supporting documentation as may be required to place
8 the Special Taxes and Improvement Area No. 1 Special Taxes on the secured property tax roll for
9 Fiscal Year 2007-08 and for the collection of the Special Taxes and Improvement Area No. 1 Special
10 Taxes in the manner of ad valorem property taxes and to perform all other acts which are required by
11 the Act, the Ordinance, or by law or deemed necessary by the Financial Services Director in order to
12 accomplish the purpose of this Resolution, the Act or District Bond or Improvement Area No. 1
13 Bond covenants.
14

15 Section 8. This Resolution shall be effective upon its adoption.



RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OCEANSIDE, ACTING IN ITS CAPACITY AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT NO. 2001-2 OF THE CITY OF OCEANSIDE (TRENDWEST RESORTS) AUTHORIZING THE LEVY OF A SPECIAL TAX FOR FISCAL YEAR 2007-08

WHEREAS, on February 6, 2002, the City Council of the City of Oceanside (the "City Council") adopted Resolution No. 02-R089-1 stating its intention to form Community Facilities District No. 2001-2 of the City of Oceanside (Trendwest Resorts) ("Community Facilities District No. 2001-2") pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, Section 53311 *et seq.* of the Government Code (the "Act"); and

WHEREAS, on February 6, 2002, the City Council also adopted Resolution No. 02-R090-1 stating its intention to incur bonded indebtedness in the amount of \$1,500,000 within proposed Community Facilities District No. 2001-2 for the purpose of financing the facilities and incidental expenses described in Resolution No. 02-R089-1 to serve the area within Community Facilities District No. 2001-2; and

WHEREAS, on March 13, 2002, the City Council adopted Resolution No. 02-R183-1 which established Community Facilities District No. 2001-2, authorized the levy of a special tax within Community Facilities District No. 2001-2 and called an election within Community Facilities District No. 2001-2 on the ballot proposition relating to levying a special tax combined and consolidated with the proposition relating to the incurring of bonded indebtedness; and

WHEREAS, on March 13, 2002, the City Council also adopted Resolution No. 02-R184-1 which determined the necessity to incur bonded indebtedness in the amount of \$1,500,000 within Community Facilities District No. 2001-2 and called an election within Community Facilities District No. 2001-2 for March 26, 2002, on the proposition of incurring bonded indebtedness combined and consolidated with the proposition of levying a special tax; and

1 WHEREAS, on March 26, 2002, an election was held within Community Facilities District
2 No. 2001-2 at which the qualified electors approved by more than a two-thirds vote the proposition
3 of incurring bonded indebtedness of \$1,500,000 and levying a special tax as set forth in Resolution
4 No. 02-R183-1; and

5 WHEREAS, on April 17, 2002, the City Council adopted Resolution No. 02-R308-1 which
6 certified the results of the March 26, 2002 election conducted by the City Clerk, which results
7 showed that more than two-thirds of the votes cast were in favor of the proposition to incur bonded
8 indebtedness and levy the special tax; and

9 WHEREAS, on May 1, 2002, the City Council adopted Ordinance No. 02-OR325-1 which
10 authorized the levy of the special tax within Community Facilities District No. 2001-2 (the
11 “Ordinance”); and

12 WHEREAS, this City Council hereby certifies that the Ordinance authorizing the levy of the
13 special taxes within Community Facilities District No. 2001-2 has been duly adopted in accordance
14 with law and is legal and valid; and

15 WHEREAS, the Ordinance provides that the City Council is further authorized to determine,
16 by ordinance, or by resolution if permitted by then applicable law, on or before August 10 of each
17 year, the specific special tax to be levied on each parcel of land in Community Facilities District No.
18 2001-2; and

19 WHEREAS, it is now necessary and appropriate that this City Council levy and collect the
20 special taxes for Fiscal Year 2007-08 for the purpose specified in the Ordinance, by the adoption of a
21 resolution as specified by the Act and the Ordinance; and

22 WHEREAS, the special taxes being levied hereunder are at the same rate or at a lower rate
23 than provided by the Ordinance;

24 NOW, THEREFORE, the City Council of the City of Oceanside acting in its capacity as the
25 legislative body of Community Facilities District No. 2001-2 does resolve as follows:
26

1 Section 1. The above recitals are all true and correct.

2 Section 2. In accordance with Section 53340 of the Act and the Ordinance, there is hereby
3 levied upon the parcels within the District which are not otherwise exempt from taxation under the
4 Act or the Ordinance the special taxes for Fiscal Year 2007-08 (the "Special Taxes"), at the tax rates
5 set forth in Exhibit A hereto and the Special Tax Consultant shall apportion the Special Taxes in the
6 manner specified in Resolution No. 02-R183-1 and the report prepared by the Special Tax Consultant
7 entitled "Administration Report Fiscal Year 2007-08" submitted herewith. Such rates do not exceed
8 the maximum rates set forth in the Ordinance. After adoption of this Resolution, but no later than
9 August 10, 2007, the Special Tax Consultant shall deliver the certified list of all parcels subject to the
10 special tax levy including the amount of the Special Taxes to be levied on each parcel in Fiscal Year
11 2007-08 (the "Certified List") to the Financial Services Director or her designee and thereafter, but in
12 no event later than August 10, 2007, the Financial Services Director or her designee shall cause a
13 certified copy of this Resolution together with the Certified List, to be filed with the County Auditor-
14 Controller. The Certified List may contain tax rates lower than those set forth in Exhibit A if the
15 Financial Services Director determines that such lower rates are adequate to accomplish the purposes
16 of the District in Fiscal Year 2007-08. The Financial Services Director or her designee and the
17 County Auditor-Controller are hereby authorized to make changes to the Certified List from time to
18 time to correct any error in the amount of the levy on any parcel to make it consistent with the rate
19 and method of apportionment attached to the Ordinance, including, but not limited to, adding any
20 parcels omitted from the Certified List or deleting any parcels included in the Certified List.
21
22

23 Section 3. Properties or entities of the state, federal or local governments shall be exempt
24 from the above-referenced and approved Special Taxes only to the extent set forth in the Ordinance
25 and otherwise shall be subject to the Special Taxes consistent with the provisions of Section 53317.3
26 of the Act in effect as of the date of adoption of this Resolution.


