AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF OCEANSIDE AMENDING CHAPTER 2 OF THE OCEANSIDE CITY CODE BY THE AMENDMENT OF SECTION 2.1.64(f) REGARDING EXPIRATION OF TERMS OF MEMBERS OF CITY BOARDS, COMMISSIONS AND COMMITTEES

WHEREAS, on February 8, 2006, the City Council of the City of Oceanside directed City staff to prepare and present for subsequent City Council approval an ordinance amending Section 2.1.64(f) of the Oceanside City Code to state that advisory group members, except for Planning Commissioners and Manufactured Home Fair Practices Commissioners, shall hold office until the expiration of their terms;

WHEREAS, on February 8, 2006, the City Council of the City of Oceanside also directed staff to revise Article II of the Planning Commission Bylaws to be consistent with the amendment to Section 2.1.64(f) of the City Code, as it pertains to the Planning Commission, specifically, to delete Subsection 2.3.3 of the Planning Commission Bylaws; and

WHEREAS, the specific amendments described above will reconcile an existing discrepancy between the Oceanside City Code and the Bylaws of the City of Oceanside Planning Commission.

NOW, THEREFORE, the City Council of the City of Oceanside does ordain as follows:

SECTION 1. Section 2.1.64(f) of the Oceanside City Code is hereby amended to read:

“Members of boards, commissions and committees shall hold office until expiration of their respective terms, except for members of the Planning Commission and the Manufactured Home Fair Practices Commission, who shall serve until a successor is appointed.”

SECTION 2. The City Clerk of the City of Oceanside is hereby directed to publish this ordinance, or the title hereof as a summary, pursuant to state statute, once within fifteen (15) days after its passage in the North County Times, a newspaper of general circulation published in the City of Oceanside.

SECTION 3. This ordinance shall take effect and be in force on the thirtieth (30th) day from and after its final passage.
