One Arrested at DUI/Driver's License Checkpoint

Oceanside, CA – Oceanside Police Department's Traffic Services Unit conducted a DUI/Driver's License Checkpoint on Friday, September 13, 2013, on Oceanside BI. west of Rancho Del Oro between the hours of 9:30 p.m. to 2:30 a.m. Officers contacted 361 drivers during the checkpoint, and arrested one driver for driving under the influence of alcohol. Eleven other drivers were determined to be currently unlicensed, while two others had suspended drivers' licenses. A total of 18 citations were issued, and nine vehicles were towed.

The deterrent effect of DUI checkpoints is a proven resource in reducing the number of persons killed and injured in alcohol or drug involved crashes. Research shows that crashes involving alcohol drop by an average of 20 percent when well-publicized checkpoints are conducted often enough.

Officers will be contacting drivers passing through the checkpoint for signs of alcohol and/or drug impairment. Officers will also check drivers for proper licensing and will strive to delay motorists only momentarily. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving. Drivers caught driving impaired can expect jail, license suspension, and insurance increases, as well as fines, fees, DUI classes, other expenses that can exceed \$10,000.

In 2011, nearly 10,000 people were killed nationally in motor vehicle traffic crashes that involved at least one driver or motorcycle rider with a blood alcohol concentration of .08% or higher. In California, this deadly crime led to 774 deaths because someone failed to designate a sober driver. "Over the course of the past three years, DUI collisions have claimed 8 lives and resulted in 164 injury crashes harming 258 of our friends and neighbors," said Sgt. Kenneth Gow.

According to the National Highway Traffic Safety Administration (NHTSA), checkpoints have provided the most effective documented results of any of the DUI enforcement strategies, while also yielding considerable cost savings of \$6 for every \$1 spent. Based on collision statistics and frequency of DUI arrests, DUI Checkpoints are placed in locations that have the greatest opportunity for achieving drunk and drugged driving deterrence. Locations are chosen with safety considerations for the officers and the public.

"DUI Checkpoints have been an essential part of the phenomenal reduction in DUI deaths that we witnessed since 2006 in California," said Christopher J. Murphy, Director of the Office of Traffic Safety. "But since the tragedy of DUI accounts for nearly one third of traffic fatalities, Oceanside needs the high visibility enforcement and public awareness that checkpoints provide."

Funding for this checkpoint is provided to Oceanside Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration, reminding everyone to continue to work together to bring an end to these tragedies.
