**APPROVAL OF THE FY 2010-2011 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM BUDGET; APPROVAL TO ALLOCATE FUNDING TO VARIOUS HOUSING AND COMMUNITY DEVELOPMENT ACTIVITIES, PLANNING, AND PROGRAM ADMINISTRATION; AND APPROVAL TO ALLOCATE GRANT FUNDING FOR VARIOUS PUBLIC SERVICES AND HOMELESS PROGRAMS**

The City will allocate \$1,788,498 of estimated 2010-2011 Community Development Block Grant (CDBG) entitlement funds and \$75,000 of estimated program income for various eligible activities. To be eligible, activities must meet one of the following National Objectives:

- 1) Primarily benefit low- and moderate-income individuals, households or neighborhoods in the City
- 2) Prevent or eliminate slums and blight
- 3) Meet an urgent local need

The City Council previously approved funding 2009-2010 public services grants for another year; no new applications were considered for 2010-2011.
