The City will use funds to pay arrears on rent or tuilities, and to pay for security deposits for homeless families who can maintain rental payments once in a rental unit. The City will work with McKinney-Vento persons at the local school districts to ensure that school-age children remain in school and that they receive any benefits to which they are entitled. The City's primary goal is to keep children in school and to assist parents to establish a realistic plan for dealing with financial issues resulting from the current economc recession. Two staff persons in the Neighborhood services Department who have experience in the Section 8 Rental Assistance Program interview families who are at risk of becoming homeless (close to eviction from rental housing) but who can become stable with support from HPRP. When households are approved the City contacts the property owner or manager to confirm that payments of past due funds will be made by the City. The City is working with local school districts for outreach to families identified by schools as homeless to ensure that students can remain in the schools of origin through HPRP assistance.
