## Annual Beach Parking Permit

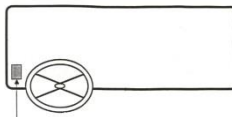
### PLEASE READ THE FOLLOWING INSTRUCTIONS

Permits are valid from July 1, 2020 through June 30, 2021. The cost is \$100.00 for residents or \$200 for non-residents. If purchased after the month of September the cost is prorated.

**PLEASE NOTE: DUE TO THE COVID-19 PUBLIC HEALTH ORDERS INTERMITTENT LOT CLOSURES MAY OCCUR. PERMIT COSTS ARE NON-REFUNDABLE.**

- **Current vehicle registration is required.**
  - If a car registration has out-of-city address a utility bill or lease agreement with an Oceanside mailing address is required as proof of residency.
  - Purchaser of Annual Beach Parking Permit must be listed on the vehicle registration.
- Lot time closures and rules will be enforced daily. Permits do not affect posted time limits. Posted time limits are enforced. Vehicles will be cited if they do not comply with enforcement laws.
- Permits are **not valid** during posted Special Events.
- The City reserves the right to make changes to the annual beach parking permit program including, but not limited to, the validity of the permit in specific lots, the availability of parking lots and spaces, and/or parking lot restrictions after issuing this permit. It is the responsibility of the permit holder to follow all posted signs and contact the City of Oceanside for any updates.
- Annual parking permits will not be issued until the buyer has cleared all outstanding parking citations.
- Permits are valid in most City & Harbor pay parking lots during posted parking lot hours only. **Permits are not valid in marked slip renter parking in Harbor lots. Permits are not valid at any street parking meters or pay lot parking meters.**
- **No overnight parking is allowed in any lot where closure times are posted. Lots 11A, 11B, 12, and 26 will require the additional overnight fee to be paid.**
- **For permanent parking decals only**- If the vehicle is stolen (police report required), sold, or the windshield is broken, a replacement permit will be available at the cost of \$10.00 upon surrender of the old decal. A new application will be required.
- For transferable hanging permits there is no replacement program. If this permit is lost, stolen or damaged you must purchase a new permit at the current monthly fee. Do not operate your vehicle with the hanger on the mirror; your view may be obstructed.

### INSTRUCTIONS FOR DISPLAYING BEACH PERMIT




The permanent decal must be affixed to the **driver's side**, lower left inside of your windshield. The hanging permit must be hung from the mirror, printed side facing outward for easy visibility. Permits displayed incorrectly or not at all will be issued parking citations. Any parking citations issued because the permit was not displayed, or displayed incorrectly, will be valid citations. # Annual Beach Parking Permit

PLEASE READ THE FOLLOWING INSTRUCTIONS

- Permit is valid from July 1, 2020 through June 30, 2021.
- Current vehicle registration and picture ID is required.
- Parking decal must be permanently affixed to the inside of your front windshield, on the lower left side.
- Hanger style parking permit must be displayed correctly, hanging from your rear view mirror facing outward, or a citation will be issued. There is no replacement program for the hangers.
- Annual parking permits will not be issued until the buyer has cleared all outstanding parking citations on any and all vehicles.

- In the event the permitted vehicle is sold or windshield broken, a replacement decal will be available at the cost of \$10 upon surrender of the old decal. A new application is required.
- **Permits are valid in City & Harbor pay parking lots during posted parking lot hours only. Permits are not valid in lots 6, 20, and 23, or slip renter parking in Harbor Lots.** 
- No commercial use defined as “no licensed business may use permit for vehicle storage or daily parking in conjunction with commercial application”.

- Permit is not valid at any street parking meter, pay lot parking meter, or signs posted for special events.
- Cost of Permit is \$100 for residents and \$200 for non-residents. If purchased after the month of September, the prorated cost is \$10 or \$20 per month through June 30<sup>th</sup>.
- **PERMIT COSTS ARE NON-REFUNDABLE.**
- No use of permits in/on trailers.
- **Other parking lot restrictions may be enforced at the discretion of the city.**
