

## Oceanside Senior Center Table Tennis Coming Soon

**Revised May, 18, 2021- PLEASE READ** in detail as there are a number of changes!

The Oceanside Country Club Senior Center at 455 Country Club Lane in Oceanside will began offering indoor **THURSDAY TABLE TENNIS starting May 27**. **THURSDAY play will also be offered on the following dates: JUNE 3, 10, 17, 24; JULY 1, 8.** Play will be restricted to **THURSDAYS ONLY** for this initial rollout. Additional days and times are anticipated to be offered as the pandemic situation improves. This soft re-opening applies only to the Country Club Senior Center on Country Club Lane. El Corazon Senior Center remains closed to all programming, including Table Tennis, at this time.

Briefly, there will be two tables available to play, each in its own enclosed area, on **THURSDAYS ONLY!!** **PLEASE, PLEASE NOTE: PLAY IS BY RESERVATION ONLY!! AT THIS TIME THERE IS NO OPEN PLAY.**

**\*\*\*\*\* IF YOU DO NOT HAVE A RESERVATION YOU WILL BE ASKED TO KINDLY LEAVE AS THE SOCIALIZING TRADITIONALLY ASSOCIATED WITH OUR GREAT PLAYERS IS SUSPENDED AT THIS TIME DUE TO RESTRICTIONS REGARDING SOCIAL GATHERINGS.\*\*\*\*\***

**REMEMBER!!!-** Access to the tables is by reservation only, maximum of four players per room. Reservations will be 1 hour for singles, an hour and a half for doubles and times will be scheduled between 9 AM and 3:30 PM. Players may be members of the same family or a team of two vaccinated individuals in order to play doubles on same side. MASKS WILL BE REQUIRED to enter and exit the building. Masks do not need to be worn while actually playing. Both playing areas will each have an open window on one end and open hallway door on the opposite end to provide maximum ventilation.

Only players who have signed a waiver of liability and agreement to abide by posted restrictions will be allowed to play. Page two of this document is the waiver. You can print, sign, scan or take picture, and email the waiver ... or you can just sign the waiver the first time you arrive to play. The email address for the signed waiver is either

Mask wearing and social distancing is required by all when entering or leaving the playing area. Each player must sign in and record personal temperature when arriving, and sign out and record temperature when departing. There will be a sign in and thermometer station for this purpose.

The vaccination requirement for doubles partnering will be self-monitored. Each group will be responsible for their own safety. Players in a group should communicate with each other and be open about vaccination, health, travel and other exposure. Whether you intend to play now or not, all players are urged to get vaccinated for their own safety and to do their part to end this pandemic so we can all return to the wonderful social and recreational environment we used to enjoy at the Senior Centers.

# Oceanside Senior Services

## Building, Facility, Property, and Parking Lot Use

### Liability Waiver

**Before participating in or observing** any recreational activity on the property or in the buildings and facilities of Oceanside Senior Center 455 Country Club Lane, Oceanside, CA 92054, every person must read the following liability waiver and sign below as an acknowledgment that he/she understands it:

1. ASSUMPTION OF RISK/RELEASE FROM LIABILITY:

In consideration of my use of the property, buildings, and facilities of Oceanside Senior Center 455 Country Club Lane, Oceanside, CA 92054, **I hereby agree to assume all risks attendant upon myself associated with such use, including but not limited to the risk of contracting the Novel Coronavirus, or COVID-19.** I hereby waive, release, and discharge any and all claims for damages for death, personal injury or property damage which I may have, or which may hereafter accrue to me, as a result of my use of Oceanside Senior Center property, parking lot, building, and/or facilities. I agree to save and hold harmless from liability City of Oceanside, all other city agencies and/or any of their agents, volunteers, or employees by reason of accident, death, injury or damage to persons or property, which my child or I may suffer while using City Parks, fields and/or recreation facilities, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

2. COVID-19 GUIDELINES: On behalf of myself, I understand and agree as follows:

I agree to follow all posted guidelines and restrictions of the CDC, State of California, County of San Diego, City of Oceanside, and Senior Center staff while using Senior Center property, parking lot, building, and/or facilities.

I agree to utilize surgical masks or improvised masks such as scarves, bandanas, buffs and handkerchiefs to reduce the risk of exposure to myself and others. I understand that this will require me to wear a mask when entering, leaving, or transiting about the Senior Center. In general, wearing a mask is mandatory whenever I am within six (6) feet of other individuals outside my own household except during posted activities for which wearing a mask is impractical.

I agree to refrain from entering the Senior Center property when experiencing abnormal symptoms of infectious disease such as, but not limited to, high fever, coughing, nausea, or achiness. I agree to depart the property if such symptoms develop while I am there. I agree to sign in upon arrival and sign out upon departure. I understand that this facilitates the tracking and notification of persons who may have been exposed to infection should any outbreaks of infectious disease occur.

to measure my temperature at the measuring station upon entering the building and to record my temperature on the sign in sheet and to depart if my temperature exceeds the posted maximum.

I agree to follow posted sanitizing and hand washing procedures for equipment use and follow safe washing or sanitizing practices after restroom use, coughing or sneezing.

I am over the age of 18 and have read, understand, and agree to all provisions of this Waiver.
