Agendas of all regular Citizen Investment Oversight Committee meetings are posted at least 72 hours prior to those meetings at the Oceanside Civic Center, 300 North Coast Highway.

Under the Brown Act, California's Open Meeting Law, any citizen has the right to address the Citizen Investment Oversight Committee on matters within the Committee's jurisdiction. However, the Committee may not discuss or take any action on any item not specifically listed on the agenda. Citizens who wish to have an item placed on the agenda may do so by contacting the City Treasurer's Office no later than two weeks prior to the date of the Committee's regularly scheduled meeting. The Citizen Investment Oversight Committee is a formally established Advisory Committee to the City Treasurer and the City Council, and as such is bound by the Brown Act.
